Our records include data that were obtained throughout your contractual relationship with us and following the various interactions between us.

If you want to keep your data and the information that "ACTIV'EVENTS" has recorded, you will not have to do anything. In addition to the situations in which we process data to comply with legal requirements, we treat your data for the following purposes:

- 1. Marketing of Products and Provision of Services Whenever necessary, to market our products as well as to provide you with our services, we treat your personal data. In addition to this, your data will also be processed for the provision of third-party services, when you have expressly consented to it.
- 2. Marketing effects Your personal data, such as name, telephone contact, email address, will be processed for the purpose of marketing or disclosing offers of goods or services from "ACTIV'EVENTS" and other companies with which has a direct relationship, if authorized. These communications are intended to inform you of news, promotions, campaigns and other opportunities that you may benefit from.

You have the right to be notified, under the terms of the Regulation, if a violation of your personal data occurs, and you can make claims before the authority (s). We guarantee all the rights enshrined in the Regulation (from the right of revocation, access, rectification and deletion, information, limitation of processing, data portability, opposition and procedural reaction) and as of 25 May 2018 you can conveniently contact us quickly and securely and make your request, which can also be sent via email, in which case it must be accompanied by documentary evidence proving the identity and / or the data to be rectified. We are committed to the protection and confidentiality of your personal data and have taken the necessary technical and organizational measures to comply with the Regulation, ensuring that the processing of your personal data is lawful, fair, transparent and limited to authorized purposes and in order to prevent its processing. loss, alteration and unauthorized access.

We have taken steps that we consider appropriate to ensure the accuracy, completeness and confidentiality of your personal data, as well as all other rights that assist you.
